Information for Students, Trainees, Fellows, and Jr. Faculty

The SRM will accept abstract submissions and the top scoring abstracts will be given the opportunity to give an oral presentation or poster presentation as well as be eligible for research awards. The abstracts will continue to be published in The American Journal of the Medical Sciences. Apply for awards as part of the abstract submission process. We strongly encourage Fellows/Jr. Faculty to submit abstracts to the 2024 meeting. This meeting offers an atmosphere that allows networking among physician-scientists.

Abstract Policies

No revisions or changes will be accepted to submitted abstracts after the deadline.

1. All abstracts are peer-reviewed and ranked on the basis of scientific merit by experts in the category selected. The Program Committee uses these rankings to develop the final meeting program. Abstracts submitted for presentation will be published at the discretion of the Southern Regional Program Committee. **The decisions of the Program Committee are final.** Abstracts will not be reviewed if received after the deadline.
2. The committee will decide on oral and poster presentations. Submitter will not be given a choice upon submission.
3. SRM requires a **nonrefundable** abstract fee of **\$85.00** to cover the costs of processing, review and/or publication. This is **separate** from the registration fee. You **must** register and pay the registration fee to attend and present your abstract at the meeting. Include separate payment with each abstract submitted. Payment must be made by credit card (American Express, Discover, MasterCard, or Visa). **No checks or purchase orders will be accepted.**
4. **INFORMED CONSENT, DISCLOSURE and COPYRIGHT:** SRM and Tulane University have adopted guidelines for conflicts of interest. Investigators must disclose potential conflicts of interest in connection with abstracts presented at the regional meetings. It is the policy of the Center for Continuing Education at Tulane University Health Sciences Center to plan and implement all of its educational activities in accordance with the ACCME's accreditation requirements and policies to ensure balance, independence, objectivity and scientific rigor. In accordance with the ACCME's Standards for Integrity and Independence in Accredited Continuing Education, everyone who is in a position to control the content of an educational activity certified for AMA PRA Category 1 Credit™ is required to disclose financial relationships or the absence of relationships with any commercial interests within the past 24 months that creates a real or apparent conflict of interest. All potential conflicts of interest must be resolved prior to the activity. Individuals who do not disclose are disqualified from participating in the CME activity. Disclosure of off-label, experimental or investigational use of drugs or devices must also be made known to the audience.

In accordance with the law, including 17 United States Code, the lecturer is liable for the making of reproductions, including photocopies, of copyrighted material. If you plan to use any copyrighted material in slides, in materials you provide for inclusion in the published abstract or for distribution, in connection with your presentation you must certify that you have received permission from the copyright holder.

Each abstract **must** comply with the following:

- (1) personal responsibility for assuring that, at the time of the meeting for which it is being considered, the material herein will not have been published; (2) the material may have been presented at another regional or national meeting with a focused audience like a subspecialty meeting, such that the material will be new to the broader audience; (3) that if accepted, an eligible author is prepared to present it; (4) that any animal studies conform with the "Guiding Principles in the Care and Use of Animals" of the American Physiological Society; (5) that any human experimentation was conducted according to a protocol approved by an Institutional Review Board on ethics of human investigation (if no such Board exists, please state in a separate letter what standards were used to assess the ethical property of the protocol); and
- (6) that potential conflicts of interest will be disclosed at time of presentation of abstract. All potential conflicts of interest should be detailed in a separate letter and uploaded with your abstract. Such information will not be available to the abstract review committee and will not prejudice review of the abstract.

Abstract Procedures

Step-by-Step Instructions for Electronic Submission. All users are considered New and must Create an Account.

To submit your abstract proceed to: <http://srm2024.abstractcentral.com>

1. The first step is to "Create an Account". Information is not saved from one year to the next. Click on the "Create an Account" link in the left side menu bar. During account creation, please bear in mind:
 - A. All fields with a red asterisk are required.
 - B. Your e-mail address is the primary method of correspondence. All system e-mails and other notifications related to the meeting will be sent to this address. Please keep your e-mail address up-to-date!
 - C. The User ID and password that you create will be needed to log into the site after your account is created. Your User ID must be at least 6 characters long and can be a combination of letters and numbers. User ID and Password are case-sensitive.
 - D. The last step in creating your account is to request a "role." For example, if you are requesting the "Abstract Submission" role, you need only check the box and you will receive the role automatically. You will then be able to submit an abstract by logging in, then clicking on the "Submission" tab at the top of the page. If you are not the presenter, you must have all of their information to complete the submission.
2. Once you have logged in using your Username and Password, click on the Submission tab at the top of page, then on the "Create a New Submission" link located on the left-hand menu bar.
3. It is recommended that you step through the submission pages in a methodical manner, going page by page and completing the information as you go along, beginning with Step 1: Title/Body page.
4. The title must be brief and indicate clearly the nature of the investigation. The title should be entered in UPPERCASE letters. **PLEASE DO NOT** enter the title in mixed case. **Abbreviations must not be used in the title.**
5. Do not include authors or institutions in the body of your abstract. Type or copy/paste each section of the abstract body into their respective fields. On **Step 1: Title/Body page**, the body of the abstract must be separated into the fields designated as: **Purpose of Study, Methods Used, Summary of Results, and Conclusions**, respectively.
6. You must complete the **Disclosure and Copyright Information** for **ALL** authors on **Step 2: Disclosure and Copyright page**.
7. There is a limit of 3000 characters for the text of your abstract submission. This **does not** include authors and institutions, only the abstract body. You may include 1 table and 1 image that **does not** count toward the character count.
8. Please enter all authors in the order they should appear in the heading of the abstract. Complete contact information for the Presenting Author and the Contact Author. Only name and email address are required for co- authors. If you (the Contact Author) are not the Presenter on an abstract, you will need to provide full contact information on the Presenter.
9. Enter all department and institutional affiliations. Department is an optional field. Only three (3) institutional affiliations will be allowed per author. You do not need to enter institutions in a particular order to be able to designate author affiliations.
10. Carefully check the proof of your abstract. Make sure all special characters and formatting is displaying properly in your proof. If you find errors, return to the appropriate page by clicking on the page name in the sidebar menu, and make your corrections.
11. If you have not completed all required sections/items you will not be able to submit your abstract. In the case of missing items, you will be prompted to enter the missing information. When all required information is entered, click "Submit" to submit your abstract. **Payment is required to complete submission of the abstract.**

Joint Plenary Session

Saturday, February 24, 2024; 9:15 AM – 11:15 AM

"Congenital Heart Disease: Examining the Spectrum of Care From Birth to Adulthood"

Congenital heart diseases refer to the range of structural defects that occur during the development of the heart. Recent investigations in the genetic and molecular causes of these defects have led to advances in the diagnosis and treatment of this condition. The focus of this plenary is to explore the genesis of congenital heart disease and to describe recent advances in clinical care.

SSCI Presidential Symposium

Friday, February 23, 2024; 8:00 AM – 10:45 AM

"The Story of Cystic Fibrosis: Gene Discovery to Drug Development"

Cystic fibrosis is caused by a mutation of the cystic fibrosis transmembrane conductance regulator (CFTR) gene. The human genome project led to the discovery of the CFTR gene sequence which led to the development of drugs that modify the effects of the CFTR gene mutation. This symposium will cover the discovery of the sequence of the CFTR, the drug development that followed this discovery, and the clinical outcomes following CFTR modulator therapies.

Manuscript Preparation and Peer-Reviewed Publication

This workshop will address in a highly interactive manner the multiple aspects of publication in scientific journals. Presenter will discuss preparation of materials, including the initial decision that the data are sufficient to justify publication. Issues related to manuscript writing will include length, focus, adherence to journal formats, and referencing. The editorial process from submission to publication will be described in-depth with particular attention to ways in which authors can interact with journal editors. Another section will cover ethical issues in publication including review boards, authorship, duplicate publication, intellectual property rights, and conflict of interest. There will be open discussion of sample manuscripts and outcomes derived from real experiences as well as time to address participant's unique questions. The presenter is Associate Editor, Dr. Sarah Sundborg Long of The Journal of Pediatrics.

Career Advancement for Clinician Educators: A Vision and a Path

Our educator faculty will be presenting this workshop for the 10th year in 2024 and will address larger issues in career development for educators. Topics include: Creating an Educator Career Plan; Managing Time: The Long and the Short; Declining Offers That Don't Contribute; Writing Skills for Publication; and Avoiding the Rut: Seeking Challenges, Mentors, and Milestones. Sessions will include case scenarios, audience participation, and didactic guidance. Attendees will be free to enter and leave the workshop to accommodate their individual needs.

Obtaining the Fellowship You Desire: Navigating the Subspecialty Match

The fellowship match presents a unique set of challenges. In this session, residency and fellowship leadership will employ case scenarios to highlight the skills development, application strategies, interview approaches, and communication methods that are most likely to yield success in the Match. Attendees will be free to enter and leave the workshop to accommodate their individual needs.

Successful Careers in Academic Medicine

The Successful Careers in Academic Medicine will discuss important aspects of career development in academic medicine. Discussions will be held about career paths, the importance of mentorship, and promotion strategy for advancement through patient care, education, and scholarly work, among other topics. Each presentation is followed by a discussion or panel presentation. Topics will range from work as clinician-educators or clinician-scientists to developing clinical programs, writing proposals and manuscripts, presentations, networking, and job negotiations. Residents, fellows, and junior faculty are welcome. At the end of the session, the audience should have a keen understanding of how to pursue successful careers in academic medicine. This year, we will identify early career faculty engaged in research who will be given special attention during the meeting. These 'Tinsley Harrison Scholars' will be invited from different academic organizations to join us at the session and participate in events specifically designed to address career development and other needs.

Clinical Case Symposium

The Adult, Pediatric and Clinical Case Symposia are devoted to the presentation and discussion of clinical case abstracts highlighting diagnostic and/or management issues. Clinical case descriptions, unique characteristics, treatment/interventions, and results/outcomes are all suitable for presentation at the Clinical Case Symposium. There will be three concurrent sessions: Adult, Neonatology and Pediatrics. At the time of abstract submission, the appropriate abstract category must be checked in order to be considered for the Adult, Neonatology or Pediatric Clinical Case Symposium.

SSCI Awards

Listed below is a description of awards for which you may apply on the abstract electronic submission form. Please choose the appropriate award on the pull-down menu if you are eligible and wish to receive an award. If the box **is not** checked, you will **not** be considered for an award. To be eligible for an award, **you must apply at the time of abstract submission**. You must choose only one award matching the award to the society(ies) to which you and your mentor belong. You must choose one society. To be eligible for the SSCI awards, you or your mentor (in the case of students and trainees) should be a member in good standing of SSCI. To apply for SSCI membership, go to <https://www.ssciweb.org/membership.php> for information and <https://www.ssciweb.org/new-membership-registration-form.php> to fill out the membership form. In the case of students, they are not eligible for membership, so only the mentor should be a member.

◆ **The Nathan Solomon & Irene Oransky-Solomon Medical Student Research Awards:** These awards (2) are offered to recognize and encourage excellence in investigation by medical students during research training. Eligibility: Medical Students or Combined MD/ PhD Students who are in research training or were in research training as of June 2023 are eligible. The applicant must be the first author of the abstract submitted in competition for the awards and plan to present the paper during the scientific sessions of the Southern Regional Meetings. Please note that it is necessary for the senior author to be a member of SSCI. Applicants for this award are encouraged to apply for the SSCI Student Award as well. For consideration of this award, the abstract has to suggest:

- 1) investigator-initiated
- 2) hypothesis-driven basic, clinical or behavioral research
- 3) conducted in a mode of discovery
- 4) whose study design, findings and conclusions satisfied the proposed hypothesis
- 5) findings have or will have the potential to advance the practice of medicine.

◆ **SSCI Student Research Award:** These awards recognize medical students and combined MD/PhD students who are currently in training and accomplished in research at the plenary session in New Orleans and award funds are intended to defray the costs for participation in the meeting. The awardee must be the first author/presenter of the abstract accepted for presentation at the 2024 meeting. SSCI awardees must be present at the SSCI Plenary session to receive this award.

◆ **SSCI Trainee Award:** These awards recognize residents and fellows who are currently in training and recognize excellence among these groups at the plenary session in New Orleans and award funds are intended to defray the costs for participation in the meeting. The awardee must be the first author/presenter of the abstract accepted for presentation at the 2024 meeting. SSCI awardees must be present at the SSCI Plenary session to receive this award.

◆ **SSCI Young Faculty Award:** The purpose of these awards is to stimulate participation by faculty at the instructor and assistant professor level. Awards will be given to the young investigators with the top rated abstract in each subspecialty as judged by a committee of the officers of SSCI. The awardee must be the first author/presenter of an abstract accepted for presentation at the 2024 meeting. SSCI awardees must be present at the SSCI Plenary session to receive this award. Only faculty at the instructor and assistant professor level are eligible for these awards.

◆ **SSCI Young Investigator Award:** The SSCI Young Investigator Awards are offered to recognize and encourage excellence in investigation by physicians and medical students during research training. Eligibility: combined MD/PhD students, interns, residents, and post-doctoral physicians who are in research training or were in research training as of June 2023 are eligible. Postdoctoral research training may be considered to extend for a period of up to three years and time spent in strictly clinical fellowships need not count against this. The applicant must be the first author of the abstract submitted in competition for the award and plan to present the paper during the scientific sessions of the Southern Regional Meetings. **Please note that it is necessary for the senior author to be a member of SSCI.** Applicants for this award are encouraged to apply for the appropriate SSCI Award as well. For consideration of this award, the abstract has to suggest: 1) investigator-initiated; 2) hypothesis-driven basic, clinical or behavioral research; 3) conducted in a mode of discovery; 4) whose study design, findings and conclusions satisfied the proposed hypothesis; and 5) findings have or will have the potential to advance the practice of medicine. **Nomination letters from the senior investigator or mentor are required and should include a statement of the candidate's role in the study. Incomplete nomination letters will deem the abstract ineligible for consideration. The letters should be received no later than October 6, 2023 and uploaded via the ScholarOne website upon submission of your abstract. ◆ **SSCI Tinsley Harrison Scholars:** These prestigious awards are for investigators (both clinical and basic research) at the level of postdoctoral fellow or instructor but before starting a tenure-track position. The purpose of these awards is to facilitate networking and career development among a community of young investigators as well as engagement with more senior leaders in SSCI who can serve as career sponsors and advisors. Airfare (tourist class), registration, and hotel expenses (up to \$1,500) will be reimbursed for the individuals chosen for these awards. Tinsley Harrison Scholars are expected to attend all required programming events in order to receive reimbursement for their travels. You do not need to be a SSCI member to apply, but if selected, you will need to join. **To apply, please send Joan Kemp (jkemp5@tulane.edu) an updated CV and a statement (300 words or less) detailing your career goals and how participation as a Tinsley Harrison Scholar fits with these goals no later than October 6, 2023. You must also submit an abstract of your original research for presentation to SRM 2024 for consideration of this award.**

SSPR Awards

Listed below is a description of awards for which you may apply on the abstract electronic submission form. Please choose the appropriate award on the pull-down menu if you are eligible and wish to receive an award. If the box **is not** checked, you **will not** be considered for an award. To be eligible for an award, **you must apply at the time of abstract submission.** You must choose only one award matching the award to the society(ies) to which you and your mentor belong. **You must choose one society.**

These awards are for work intimately related to pediatric research. MUST be an SSPR member or have a sponsor who is an SSPR member. The candidates must check the appropriate award box in order to be considered. You cannot apply for the other society awards if applying for SSPR Awards. The Member/Sponsor name must also be filled in on the electronic submission form.

◆ **SSPR Young Investigator Award:** Eligible candidates include students, residents, fellows, and young faculty who are currently within 5 years of the completion of fellowship training. The nominee must be first author/presenter of the abstract accepted for presentation. A letter from the senior investigator or sponsor that includes a statement that the work was performed by the nominee and fully addresses the role the candidate had in the work must be received by October 6, 2023 and uploaded via the ScholarOne website upon submission of your abstract. For further information contact Jay Kerecman MD; Secretary-SSPR; (jkerecman@gmail.com). Three finalists for Basic or Clinical Science research will be selected and are required to submit a manuscript (for purposes of this competition only) and present the study results at the SSPR Plenary Session at the 2024 SRM meeting. Finalists will receive a stipend of \$500 to facilitate attendance at the meeting. Candidates must check the appropriate award box in order to be considered and must designate either Basic or Clinical Science Division.

◆ **SSPR Young Faculty Travel Award:** The candidate must be an Instructor or Assistant Professor and within 5 years of the completion of fellowship training. They must be first author/presenter of the abstract accepted for presentation. Approximately 5 awardees will receive a travel stipend of \$500. Faculty that are candidates for the SSPR Young Investigator Awards will automatically be entered in this competition. This award is to facilitate travel for outstanding young faculty.

◆ **SSPR/APA Trainee Travel Award:** The candidate must be a student, resident, or fellow. They must be the first author/ presenter of the abstract accepted for presentation. Approximately 25 winning candidates will receive a travel stipend of \$500. Trainees that are candidates for the SSPR Young Investigator Awards will automatically be entered in this competition.

◆ **SPR Diversity in the Pediatric Research Workforce Travel Award:** This award provides support for a Southern Region researcher to attend and present their work at the Pediatric Academic Societies Meeting. Eligible: background is Black or African American, Hispanic or Latinx, American Indian or Alaska Native, Native Hawaiian or other Pacific Islander. Southern Awards

Nomination letters are required for consideration of these awards. Incomplete nomination letters will deem the abstract ineligible.
